

Terms and Conditions for 12th Bonanza Lucky Draw (1st February 2023 - 30th April 2023)

1) Entry Eligibility:

- a) Bonanza Lucky Draw contest is open to all customers who are 18 years old and above.
- b) Wholesaler, employees of TCE Tackles and their immediate family members (spouse, children, parents, siblings and their spouses) are ineligible to enter the contest. (TCE Tackles Sdn. Bhd. was known as “The Organizer”)

3) Submission of Entries:

a) Purchase **RM 50 and above in single receipt**, eligible to take part in 12th Bonanza Lucky Draw **at any TCE Tackles Malaysia outlets.**
